AND ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to ASSIGNEE any facts known to it respecting said improvements, and testify in any legal proceeding, sign all lawful papers, and generally do everything possible to aid ASSIGNEE to obtain and enforce all legal rights available for said improvements in all countries.


