
ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT is made and entered into effective as of April 25, 2017 (the "Effective Date"), by and between Mr. Hao Ni, an individual ("Assignor"), and OpenPeak LLC, a Texas limited liability company organized under the laws of Texas and having offices at 1708 Harrington Dr. Plano TX 75075 ("Assignee") (with collective reference to Assignor and Assignee, the "Parties").


WHEREAS, pursuant to that certain Order Authorizing Sale of Assets of OpenPeak, Inc. Free and Clear of All Liens, Claims, Interests and Encumbrances Pursuant to 11 U.S.C. §§ 363(b), (f), and (m), dated April 19, 2017, entered in the Chapter 7 Case of OpenPeak, Inc. issued in the United States Bankruptcy Court for the District of New Jersey (case no. 16-28464 (SLM) (dkt. no. 80) (the "Sale Order"), that certain Trustee's Bill of Sale, dated April 24, 2017, wherein the Trustee for the estate of OpenPeak, Inc., in exchange for valuable consideration from Assignor or his assigns, sold, conveyed and assigned to Assignor or his assigns all of the present and future right, title, and interest in and to all of the technology and intellectual property of OpenPeak, Inc. (the "Bill of Sale"), and that certain Intellectual Property Asset Purchase Agreement, dated April 24, 2017, wherein the Trustee for the estate of OpenPeak, Inc., in exchange for valuable consideration from Assignor on behalf of Assignee, sold, transferred, assigned conveyed and delivered to Assignee all rights, title and interest in all of the technology and intellectual property of OpenPeak, Inc. (the "Purchase Agreement") (with collective reference to the Sale Order, Bill of Sale and the Purchase Agreement, the "Documents").

NOW THEREFORE, to the extent Assignor has any right, title or interest in or to any assets pursuant to the Documents (collectively, the "Assets"), Assignor, as of the Effective Date, and without warranty of any kind (express or implied), sells, transfers, assigns and sets over to Assignee the Assets, including, as applicable: rights, title and interest (for all countries) to the Assets; royalties, claims, damages and payments now or hereafter due or payable with respect to the Assets; and all causes of action (whether in law or equity) and the right to sue, counterclaim, and recover for the past, present and future infringement in connection with the Assets.
