PATENT ASSIGNMENT

WHEREAS, OMNIPROBE, INC., a Texas corporation having a principal place of business at 300 Baker Ave. Suite 150, Concord, MA 01742-2124, USA ("ASSIGNOR"), is the owner of the entire right, title and interest in and to the following described United States re-issue patent : RE46,350, issued March 28, 2017, and titled "Method for stem sample inspection in a charged particle beam instrument" ("the PATENT").

ASSIGNEE may apply for and receive patents in its own name wherever so permitted by law and ASSIGNOR shall, when requested by ASSIGNEE, execute or cause to be executed all rightful oaths, assignments, and powers of attorney to ASSIGNEE or to agents and legal representatives of ASSIGNEE, and all other papers necessary and proper to carry out the intent and purpose of this Assignment, and ASSIGNOR further agrees:

to execute all papers necessary in connection with the PATENT, and any continuing, divisional, reissue, reexamination or other corresponding application thereof and to execute any separate Assignment in connection with such application as ASSIGNEE may deem necessary or expedient; and

to perform all affirmative acts which may be necessary to obtain a grant of a valid patent to ASSIGNEE on any of the PATENT and on any continuation, division, reissue or reexamination of any of the PATENT. ASSIGNOR retains no ownership rights in the PATENT and the rights transferred to ASSIGNEE hereunder.

And for the same consideration, ASSIGNOR sells, transfers, and assigns to ASSIGNEE all damages for past infringements of the PATENT.
