FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “**Amendment**”) is made as of the 27th day of December, 2017 by ENSIGHTEN, INC., a Delaware corporation (the “**Grantor**”), and SILICON VALLEY BANK, a California corporation (“**Bank**”).

RECITALS

WHEREAS, Bank previously agreed to make certain advances of money and to extend certain financial accommodations to Grantor (the “**Loans**”) in the amounts and manner set forth in a certain (i) Amended and Restated Loan and Security Agreement by and between Grantor and Bank dated as of September 30, 2014 (as the same may be amended, modified, supplemented or restated from time to time, the “**Senior Loan Agreement**”) and (ii) Loan and Security Agreement (Mezzanine Facility) by and between Grantor and Bank dated as of May 12, 2015 (as the same may be amended, modified, supplemented or restated from time to time, the “**Subordinated Loan Agreement**”);

WHEREAS, in order to secure Grantor’s Obligations under the Loans, Grantor entered into that certain Intellectual Property Security Agreement dated May 12, 2015 in favor of Bank (as thereafter amended, restated, substituted or otherwise modified, the “**IP Security Agreement**”) in connection with Grantor’s granting to Bank a first priority security interest in all of Grantor’s right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral;

WHEREAS, Grantor and Bank desire to replace, amend and restate certain provisions of the Senior Loan Agreement pursuant to that certain Second Amended and Restated Loan and Security Agreement by and between Bank and Grantor of even date herewith (the “**Loan Agreement**”); and

WHEREAS, in connection with the Loan Agreement, Grantor and Bank have agreed to enter into this Amendment to amend and restate Exhibit B of the IP Security Agreement and to make such other changes to the IP Security Agreement as are more particularly set forth herein.

AGREEMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed to them in the Loan Agreement or the IP Security Agreement, as applicable.
2. The Recitals set forth hereinabove are hereby incorporated by this reference with the same force and effect as if fully set forth herein.
3. Grantor and Bank acknowledge and agree that Exhibit B of the IP Security Agreement is hereby replaced in its entirety with Exhibit B attached hereto.

4. Grantor does hereby unconditionally reaffirm all of its obligations to Bank under the IP Security Agreement including, without limitation, the grant of a continuing security interest in and lien upon the Intellectual Property Collateral as set forth in the IP Security Agreement as modified hereby.

5. Grantor certifies that the representations contained in the IP Security Agreement remain true, correct and complete in all material respects as of the date hereof with the same force and effect as if made on the date hereof and that it has no offsets, counterclaims or defenses to any of its obligations under the IP Security Agreement as modified hereby.

6. Except as modified hereby, the IP Security Agreement remains unmodified and in full force and effect.


7. This Amendment may be executed in any number of counterparts and all of such counterparts taken together shall be deemed to constitute one and the same instrument.
