Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks and all authorized officials of foreign patent offices to issue any and all patents for said invention to the Assignee as the owner of the entire interest, for the sole use and benefit of the said Assignee, its successors, assigns and legal representatives.

Assignor hereby agrees to sign all lawful papers and to perform all other lawful acts which the Assignee may request of Assignor to make this Assignment fully effective, including, by way of example but not of limitation, the following:

Prompt execution of all original, divisional, continuation, continuation-in-part, substitute, reexamination, reissue, and other United States and foreign patent applications for said invention, and all lawful documents requested by the Assignee to further the prosecution of any of such patent applications.

Cooperation to the best of the Assignor's ability in the execution of all lawful documents, the production of evidence and providing of testimony in connection with nullification, reissue, reexamination, extension, infringement or other post-issuance proceedings involving said invention upon the request of the Assignee, or its successors or assigns.

This assignment and agreement shall be binding upon Assignor's heirs and legal representatives.

In addition, notice is hereby provided that the Assignee has granted, by separate agreement, to Junjie Dai and Jinbao Chen (the "interest holders") a security interest in an undivided one half interest in all of Assignee's right, title and interest to (1) any applications based on the invention and (2) patents, if any, issuing from those applications.
