**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS (this "Agreement") dated as of January 30, 2018, from Abacus Finance Group, LLC, in its capacity as administrative agent for the Lenders (referenced in the Patent Security Agreement defined below) (the "Administrative Agent"), in favor of Pacific Handy Cutter, Inc., a California corporation (the "Grantor").

WITNESSETH:

WHEREAS, in connection with the Patent Security Agreement, dated as of August 10, 2016 (the "Patent Security Agreement"), the Administrative Agent was granted a security interest in all of its right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement) from the Grantor (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Patent Security Agreement);

WHEREAS, the Patent Security Agreement was recorded in the Patent Assignment Division of the United States Patent and Trademark Office (the "USPTO") on August 12, 2016 at Reel 039423 and Frame 0528; and

WHEREAS, the Administrative Agent now wishes to release its liens on, and security interests in, the Patent Collateral, including, without limitation, the patents as set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Administrative Agent hereby states as follows:

1. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges all of its security interest in the Patent Collateral, and reassigns any and all right, title and interest that it may have in or to the Patent Collateral to the Grantor.


2. Recordation. The Grantor or its authorized agent is authorized to record this Agreement with the USPTO.

3. Governing Law. This Agreement and the rights and obligations of the parties under this agreement shall be construed in accordance with and governed by the laws of the State of New York.

4. Further Assurances. The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at Grantor's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
