RESOLVED: That the merger of this Corporation's wholly owned subsidiary, Advanced Technology Materials, Inc. with and into this Corporation in accordance with Section 253 of the Delaware General Corporation Law, be, and it hereby is, approved, and the Senior Vice President & General Counsel be, and he hereby is, authorized and empowered to execute, acknowledge and file with the Secretary of State of Delaware a certificate of ownership and merger setting forth this resolution in order to effect such merger.
