

Furthermore, for good and valuable consideration, the receipt of which is acknowledged, I hereby also sell, assign, and transfer unto Cirrus Logic International Semiconductor Ltd. the entire right, title, and interest in and to the Invention and in and to all applications related to the Invention for all countries foreign to the United States of America, including but not limited to all rights under any and all international conventions and treaties in respect of the Invention and the applications for Letters Patent, utility models, utility patents, design patents, supplementary protection certificates, patent certificates, and all similar protections in all countries foreign to the United States of America, and I further authorize and assign all rights to Cirrus Logic International Semiconductor Ltd. to apply for Letters Patent, utility models, utility patents, and patent certificates in all countries foreign to the United States directly in its own name, and to claim priority of the filing date of an application for the earliest-filed patent application(s) for the Invention under the provisions of any and all laws, international conventions, treaties, or otherwise.


