I covenant that I am the lawful owner of the said application, apparatus, inventions, discoveries and improvements, that the same are unencumbered, that no license has been granted to make, use, or vend the said apparatus, inventions, discoveries or improvements or any of them, and that I have the full right to make this Assignment.


The undersigned hereby authorizes and requests the attorneys of record in said application to insert in this Assignment the filing date and serial number of said application when known.


