WHEREAS, on or before the Effective Date, IIX was owner of the entire right, title and interest in and to the PRC Application(s) by virtue of the Inventor(s)’ employment;

WHEREAS, IIX executed a certain assignment entitled “Non-PRC Assignment of PRC Priority Application(s)” effective *nunc pro tunc* as of November 25, 2013 (“First Assignment”), purporting to assign its entire non-PRC right, title and interest in and to the PRC Application(s) to IML;

WHEREAS, the Inventor(s) executed a certain assignment entitled “Assignment to Business Concern” on September 28, 2015 (“Second Assignment”), purporting to assign their entire right, title and interest in and to the corresponding U.S. Patent Application No. 14/553,705 and “any foreign patents or patent applications corresponding thereto” to IRC;

WHEREAS, IRC executed a certain assignment entitled "Assignment of Intellectual Property" on April 18, 2016 ("Third Assignment"), assigning their entire right, title and interest in and to the corresponding U.S. Patent Application No. 14/553,705 (which published as US 2015/0147503) and the corresponding International Patent Application No. PCT/US2014/067457 (which published as WO 2015/077788) to IML;

WHEREAS, as of the Effective Date and before the Third Assignment on April 18, 2016, it was the intent of the Parties for IRC to own all non-PRC right, title and interest in and to the inventions and/or designs disclosed in the PRC Application(s);

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Parties hereby agree as follows:

**The Parties hereby agree that this Corrected Assignment does not impact or change the Third Assignment in any manner.**

IIX, the Inventor(s), to the extent the Inventor(s) still have any rights by virtue of their inventorship, and IML, to the extent IML still has any rights by virtue of the First Assignment (collectively, the "Assignors"), their successors and assigns do hereby, effective *nunc pro tunc* as of the Effective Date, assign unto IRC (the "Assignee") the full, entire and exclusive non-PRC right, title and interest in, to, and under, including all priority rights, to the inventions and/or designs disclosed in the PRC Application(s) and any and all intellectual property rights including, but not limited to, patents, registered designs, copyrights, and unregistered design rights in and of all non-PRC countries including, but not limited to, Canada, the EPO and its member states, Mexico, and the United States, whether or not claiming priority thereto including, but not limited to, any child applications, Patent Cooperation Treaty applications, Hague Convention applications, continuations, continuations-in-part, divisionals, reexaminations, renewals, reviews, substitutes, extensions and/or reissues thereof, and any patents, registered designs, copyrights, unregistered design rights, or other intellectual property rights resulting therefrom and including the right to sue for past infringement for its own use and enjoyment to the full end of the term(s) for which said rights may be granted or subsist, as fully and entirely as the same would have been held and enjoyed by the Assignors had this assignment and sale not been made. With the exception of the priority rights to the PRC Application(s), the right, title, and interest to the respective PRC Application(s) is not subject to this assignment.
