For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor hereby unconditionally and irrevocably assigns, transfers and conveys to Assignees, their successors and assigns, all of its world-wide right, title, and interest, in, to, and under the Assigned Patents, including, but not limited to, all inventions disclosed in the Assigned Patents and all benefits, privileges, causes of action, and remedies relating to such Assigned Patents, including, without limitation, the exclusive rights to (a) apply for and maintain all registrations, renewals, divisions, reissues, continuations, continuation-in-parts, extensions thereof, and any applications claiming priority thereto, in accordance with 35 U.S.C. §261, (b) the right to claim for any applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries, (c) all rights and causes of action to recover past, present, or future damages, royalties, fees, profits, or other relief, including but not limited to, equitable and injunctive relief ensuing from past, present and future infringement of Assigned Patents, (d) grant licenses or other interests therein and (e) otherwise fully and entirely stand in the place of Assignor in all matters related thereto.

3. Representations and Warranty. Assignor represents and warrants that Assignor has the ability to convey all rights and interests herein assigned, and that Assignor has not licensed, encumbered, assigned, transferred, conveyed, or pledged to any person or entity, the Assigned Patents.

4. Further Assurances. Assignor shall execute any instruments or documents and perform all other acts reasonably necessary or appropriate, in the reasonable discretion of the Assignees, by Assignees to further evidence the intent and purpose of this Assignment.

5. Entire Agreement. This Assignment, together with Schedule 1, constitutes the sole and entire agreement of the Parties to this Assignment with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations and warranties, both written and oral, with respect to such subject matter.

6. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

7. Governing Law. The laws of the State of Florida, without giving effect to its conflicts of laws principles, shall govern all matters arising out of, in connection with, or relating to this Assignment including, without limitation, the validity, interpretation, construction, performance, and enforcement thereof.

8. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.
