THIS ASSIGNMENT is made the 14th day of January 2019

BETWEEN

- (1) SIMON BRIAN LAIGHT, holder of British passport number , at 36 Westfield Road, Edgbaston, Birmingham, B15 3QG, United Kingdom (the "Assignor"); and
- (2) LAIGHT DESIGNS LIMITED, a company incorporated in United Kingdom (company number 11631921) and having its registered office at 36 Westfield Road, Edgbaston, Birmingham, B15 3QG, United Kingdom (the "Assignee").

WHEREAS

- (A) The Assignor has contributed to the development of a stand for locating a wheel of a wheeled vehicle that is the subject of the patent applications set out in Annexure A of this Assignment (the "Invention").
- (B) The Assignor has agreed to assign all its rights, title and interest in and to the Invention to the Assignee on the terms set out in this Assignment.

NOW IT IS HEREBY AGREED as follows:

1. In consideration of the sum of One Hong Kong Dollar (HK\$1.00) and other good and valuable consideration paid by the Assignee (the receipt and sufficiency of which is hereby acknowledged) the Assignor assigns to the Assignee absolutely all its entire right, title and interest in and to the Invention and the full and exclusive benefit thereof, including without limitation:
 - (a) the right to file patent, utility model and/or design applications in respect of the Invention and any improvements thereon ("IP Applications"), and to pursue and obtain other forms of legal protection in respect of the Invention and any improvements thereon, anywhere in the world;
 - (b) the right to claim priority from any such IP Applications;
 - (c) the right to file convention, divisional, continuation, continuation-in-part, substitution, reissue, renewal, re-examination, continued prosecution ("CPA") applications and/or a request for continued examination ("RCE") in respect of any such IP Applications;
 - (d) the right to prosecute and obtain grant of patent and/or other intellectual property rights based on or relating to any of the above applications anywhere in the world;
 - (e) the absolute entitlement to any patent rights granted pursuant to any of the above applications; and
 - (f) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership of any patent or other legal rights granted in respect of the Invention or any improvements thereon, whether occurring before, on or after the date of this Assignment.

2. The Assignor hereby covenants with the Assignee that the Assignor shall at the expense of the Assignee promptly execute, sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee or its nominee to enjoy the full benefit of the rights assigned by this Assignment. For the avoidance of doubt, the Assignee specifically covenants with the Assignor that the Assignee shall promptly execute any documents in relation to the filing, prosecution and registration of any IP Applications or any other applications referred to in clause 1, anywhere in the world, by the Assignor or its nominee.
3. The Assignor further covenants with the Assignee that the Assignor has not done or knowingly suffered or been party or privy to any act or thing whereby the Assignor is prevented from validly assigning the rights referred to in clause 1.
4. Each party shall, and shall use all reasonable endeavours to procure that any necessary third party shall promptly execute and deliver such documents and perform such acts as may be required for the purpose of giving full effect to this Assignment.
5. This Assignment constitutes the entire agreement between the parties and supersedes and extinguishes all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.
6. Each party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this Assignment. Each party agrees that it shall have no claim for innocent or negligent misrepresentation or negligent misstatement based on any statement in this Assignment.
7. In this Assignment the expressions "Assignor" and "Assignee" shall, where the context so admits, include their respective successors, heirs and assigns.
8. This assignment may be executed in any number of counterparts, each of which when executed and delivered shall constitute an original of this assignment, but all the counterparts shall together constitute the same assignment. No counterpart shall be effective until each party has executed at least one counterpart.
9. This Assignment shall be governed by and interpreted in accordance with the laws of England and Wales and the parties hereby submit to the exclusive jurisdiction of the Courts of England and Wales.
