AND the foregoing assignment includes all rights to sue for past, present, and future infringement, including the right to collect and receive any damages, royalties, or settlements for such infringements, all rights to sue for injunctive or other equitable relief, and any and all causes of action relating to the Patents or the aforesaid related patents or applications;

AND Assignor hereby agrees to execute without further consideration any further documents and instruments which may be necessary, lawful and proper in the prosecution of said above-referenced Patents, or in the preparation or prosecution of any patents and applications claiming priority to and/or benefit of, directly or indirectly, or based in whole or in part on, one or more of said Patents including any continuation, continuation-in-part, divisional, substitute, renewal, reexamination or reissue applications, or in any amendments or extensions, that may be necessary to secure to Assignee its interest and title in and to said Patents and applications;

AND Assignor hereby covenants that Assignor has the full right to convey the entire interest herein assigned, and that Assignor has granted no right or license to make, use, sell or offer to sell said Patents, to anyone except said Assignee, that prior to the execution of this deed, Assignor's right, title and interest in said Patents had not been otherwise encumbered, and that Assignor has not and will not execute any instrument in conflict therewith;

AND Assignor hereby authorizes and requests the Director of the United States Patent and Trademark Office, and any officials of foreign countries whose duty is to issue patents on applications as aforesaid, to issue any and all letters patents which may be granted upon said United States and foreign applications or upon the Patents to the Assignee.
