Assignor authorizes and empowers the Assignee, its successors, assigns and legal representatives, or nominees to invoke and claim for any application for patent or other form of protection for the inventions the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from Assignor; and

Assignor hereby consents that a copy of this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file, or like document which may be required for any purpose and more particularly in proof of the right of the Assignee, its successors, assigns and legal representatives, or nominees to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it; and
4. Assignor hereby covenants that Assignor has the full right to convey the entire right, title and interest herein assigned and Assignor has not executed and will not execute any agreement in conflict herewith; and
5. Assignor hereby covenants and agrees that Assignor will communicate to the Assignee, its successors, assigns and legal representatives, or nominees all facts known to Assignor pertaining to the inventions, and testify in all legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue applications and foreign counterparts, make all rightful oaths and declarations and in general perform all lawful acts necessary or proper to aid the Assignee, its successors, assigns and legal representatives, or nominees in obtaining, maintaining and enforcing all legal patent protection for the inventions; and
6. Assignee hereby acknowledges receipt of the entire right, title and interest in and to the aforementioned patents and patent applications.

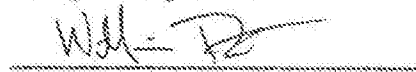

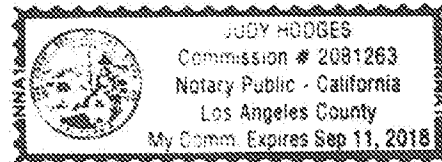

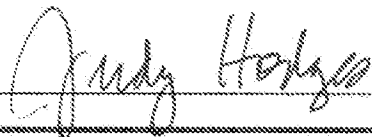
