AND I do hereby authorize and request the issuing authority to issue any and all of said United States and foreign patents on said **APPLICATION** or related applications to the **ASSIGNEE**, its successors and assigns, as the assignee of the entire right, title and interest in and to the same, for the sole use and benefit of said **ASSIGNEE**, its successors and assigns.

will do all lawful acts and things, make all rightful oaths, and make, execute, and deliver any and all other instruments in writing, and any and all further applications, papers, powers, affidavits, assignments, disclaimers and other documents, which in the opinion of counsel for said ASSIGNEE, its successors and assigns, may be required or necessary in this or in any foreign country more effectually to secure to and vest in the ASSIGNEE, its successors and assigns, the entire right, title and interest in and to said invention, inventions, or improvements, APPLICATION or related applications, patents, rights, titles, benefits, privileges and advantages hereby sold, assigned, confirmed, transferred and conveyed.

The undersigned hereby grant(s) David P. Gordon, Esq., David S. Jacobson, Esq., Jay P. Sbrollini, Esq. and Christian Mannino, Esq. the power to insert on this Assignment any further identification which may be necessary in order to comply with the rules of the U.S. Patent and Trademark Office for the recordation of this document and to correct any errors or defects herein.
