country, that may be necessary to secure to Assignee its interest and title in and to said Inventions or any parts thereof, and in and to said applications and patents;

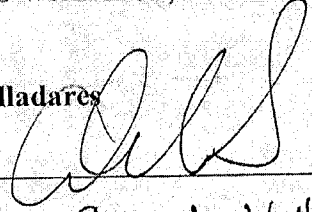

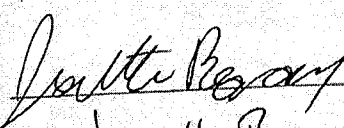

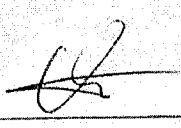
