
make such patent applications as necessary and determined solely by the Assignee to preserve the rights of the parties;

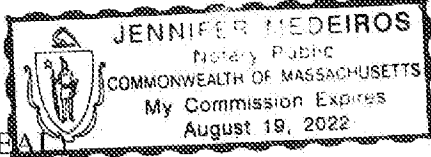


