NOW, therefore, Assignor hereby assigns all rights to any designs, artwork, mock-ups, materials, ("Work" or "Works") that are included in the work performed for client in the creation of the Work:

1. "Works" includes all works whenever created by Assignor for the benefit of Tom's Town with regard to bottle designs, whether before or after the execution date of this Agreement.
2. Any Work created before the execution date is hereby assigned by Assignor to Assignee as of the date of creation of the Work and any Work created after execution of this Agreement is hereby assigned by Assignor to Assignee as of the date of creation of the Work.
3. In return for the aforementioned consideration, Assignor does hereby assign and transfer unto Assignee all Work and all rights in said Work, inclusive of copyright, trademark, design patent or other proprietary rights, throughout the United States of America and all foreign countries, including the right to register and exercise the rights of

patent, copyright or trademark as owner, to use and enjoy the benefits of said Work, to license the Work and the related rights to third parties in the sole discretion of Assignee and the right to modify, change, or create derivative works from the Work. Assignor hereby assigns ALL rights without reservation to the Work to Assignee.

4.1 Assignor also assigns, to the extent such rights remain with Assignor, the right to sue for past, current or future infringements of said copyright.

5.1 Upon request of Assignee, Assignor will assist in the execution or support of any documentation required to register the Work in the name of Assignee. Any expenses relating to such registration or support will be borne by Assignee.

6.1 Assignee hereby grants Assignor right in perpetuity to display the Works in portfolios, design books, digitally or through any known and future media for promotional purposes.

Assignor therefore signs below and completely assigns, transfers, and conveys all rights with regard to approved bottle designs and related labels and art work to the Assignee.

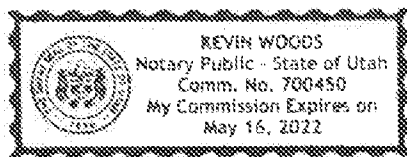


