JUDGMENT OF POSSESSION

Considering the petition for possession of the surviving sole legatee and the record of these proceedings, the Louisiana Inheritance and Estate Transfer Tax return is no longer required in the succession filed herein there will be no return necessary and none anticipated, the law and the evidence entitling petitioners to the relief prayed for:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

I. That Bonnie Elizabeth Taylor as sole surviving legatee of all property, real, personal, separate and community property of decedent, all without bond or separate inventory, be and she is hereby recognized as sole owner and sent into possession of decedent's following property;

Anderson, said steel stake is in the East right of way line of FM Highway No. 92, and is 60 feet perpendicular distance from its centerline:

THENCE N 11°48' E with said right of way line 342.68 feet to an iron pin for corner;

THENCE S 78° 12' E 250.00 feet to an iron pin for corner;




