THIS AGREEMENT is dated

14th January

2019

BETWEEN:

- (1) **MAHABIS LIMITED** (In Administration) a company registered in England under number 09049323 whose registered office is Irish Square, Upper Denbigh Road, St Asaph, Denbighshire, United Kingdom, LL17 0RN (the "Assignor") acting by its Administrators;
- (2) **GARETH WYN ROBERTS and PAUL WILLIAM ELLISON** both of KRE Corporate Recovery LLP, whose registered number is OC378666, whose registered office is Burlington House, 1-13 York Road, Maidenhead, Berkshire, SL6 1SQ (the "Administrators"); and
- (3) **21K FOOTWEAR LIMITED**, a company incorporated and registered in England and Wales with company number 11758898, whose registered office is at 21 Knightsbridge, London, United Kingdom, SW1X 7LY ("Assignee"); and

BACKGROUND:

- (A) The Assignor is the legal and beneficial owner of the Assigned Rights (as defined below).
- (B) The Administrators were appointed by the directors of the Assignor as joint administrators of the Assignor on 27 December 2018 pursuant to paragraph 22 of schedule B1 to the Insolvency Act 1986.
- (C) Pursuant to a sale and purchase agreement dated on or about today's date between the Assignor, the Administrators and the Assignee (the "Sale Agreement"), the Assignor acting by the Administrators agreed to enter into an assignment on the terms set out below.

NOW THIS DEED WITNESSES as follows:

1 DEFINITIONS AND INTERPRETATION

1.1 The following definitions and rules of interpretation apply in this Agreement.

"Agreed List"	the list agreed between the Parties and for the purpose of identification initialed by them and annexed to this Agreement;
"Assigned Rights"	the Trade Marks, the Registered Designs, the Copyright, the Domain Names, the Mould Rights, the M Logo and Project Rights, and all other Intellectual Property Rights, works and materials which are vested in, owned or used by the Assignor and relate to the Assignor's Business;
"Business"	the business of shoe production and distribution;
"Business Day"	a day other than a Saturday, Sunday or public holiday in England when banks in England are open for business;
"Copyright"	the records of copyright and the applications therefor, short particulars of which are set out in the Agreed List;
"Domain Names"	the domain names which are set out in the Agreed List;
"Intellectual Property Rights"	all copyright and related rights, database rights, confidential information, trade secrets, know-how, business names, trade names, trade marks, service marks, passing off rights, unfair competition rights, patents, petty patents, utility models, semi-conductor

topography rights, rights in design, and all, and all claims to, other intangible or intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world;

"M Logo and Project Rights"	all Intellectual Property Rights in the stylised "M" logo created for and on behalf of Shah Corporation Limited by IYA Studio Limited pursuant to a brand development and design project between those parties dated 16 May 2013, as represented in the International trade mark registration number IR1370357 set out in the Agreed List, and all other Intellectual Property Rights created by IYA Studio Limited for and on behalf of Shah Corporation Limited pursuant to that project and as assigned by IYA Studio Limited to Shah Corporation Limited pursuant to an assignment dated 26 November 2013 (as subsequently assigned by Shah Corporation Limited to Shah Corporation 2 Limited on 08 May 2015);
"M Logo and Project Rights Assignments"	the assignment agreement between IYA Studios Limited and Shah Corporation Limited dated 26 November 2013 and the assignment agreement between Shah Corporation Limited and Shah Corporation 2 Limited on 08 May 2015);
"Mould Rights"	any Intellectual Property Rights subsisting in the moulds owned by, or used by, for or on behalf of, the Assignor to make certain of the Business' products;
"Parties"	the Assignor acting by the Administrators and the Assignee, and Party shall be construed accordingly;
"Registered Designs"	the registered designs and the applications therefor, short particulars of which are set out in the Agreed List;
"Trade Marks"	the registered trade marks and the applications therefor, short particulars of which are set out in the Agreed List;
"VAT"	value added tax chargeable under the Value Added Tax Act 1994.

- 1.2 Clause headings shall not affect the interpretation of this Agreement.
- 1.3 A person includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).
- 1.4 References to Clauses are to the clauses of this Agreement.
- 1.5 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.6 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.7 A reference to a statute or statutory provision is a reference to it amended, extended or re-enacted from time to time.

- 1.8 A reference to a statute or statutory provision shall include any subordinate legislation made from time to time under that statute or statutory provision.
- 1.9 A reference to "writing" or "written" includes email (provided the email is supported by a valid server delivery receipt).
- 1.10 Any words following the terms "including", "include", "in particular", "for example" or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.
- 1.11 References to the Administrators shall be construed as being to the Administrators both jointly and severally and to any other person who is appointed as an administrator in substitution for any administrator or as an additional administrator in conjunction with the Administrators or to any subsequently appointed liquidators of the Assignor.

2 ASSIGNMENT

In consideration of the payment of £1.00, receipt of which is hereby acknowledged, the Assignor hereby assigns to the Assignee absolutely:

- 2.1 such right, title and interest as it has in and to the Assigned Rights, including those assigned to it by Shah Corporation 2 Limited pursuant to an assignment of intellectual property rights entered into on or about today's date;
- 2.2 any registrations granted pursuant to any of the applications comprised in the Assigned Rights;
- 2.3 such goodwill in and attaching to the Trade Marks and any other trade marks forming part of the Assigned Rights as is vested in the Assignor;
- 2.4 the entitlement to control, and administrative access to, the Domain Names, and the right, power and authority to deal with the Domain Names without restriction to the extent that the same are vested in the Assignor;
- 2.5 the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Assigned Rights whether occurring before, on, or after the date of this Agreement (together, the "Actions"); and
- 2.6 in respect of any dealings that relate to the Assignor's Business, including without limitation the Actions, the entitlement to disclose the information contained in, and copies of, in each case without restriction, the M Logo and Project Rights Assignments.

3 VAT

All payments made by the Assignee under this Agreement are exclusive of VAT. If any such payment constitutes the whole or any part of the consideration for a taxable or deemed taxable supply by the Assignor, the Assignee shall increase that payment by an amount equal to the VAT which is chargeable in respect of the taxable or deemed taxable supply provided that the Assignor shall have delivered a valid VAT invoice in respect of such VAT to the Assignee.

4 FURTHER ASSURANCE

- 4.1 At the Assignee's expense the Assignor shall, and shall use all reasonable endeavours to procure that any necessary third party shall, promptly execute and deliver such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this Agreement, including:

- 4.1.1 registration of the Assignee as applicant or (as applicable) proprietor of the Assigned Rights; and
- 4.1.2 assisting the Assignee in obtaining, defending and enforcing the Assigned Rights, and assisting with any other proceedings which may be brought by or against the Assignee against or by any third party relating to the Assigned Rights.
- 4.2 The Assignor appoints the Assignee to be its attorney in its name and on its behalf to execute documents, use the Assignor's name and do all things which are necessary or desirable for the Assignee to obtain for itself or its nominee the full benefit of this Agreement.
- 4.3 This power of attorney is irrevocable and is given by way of security to secure the performance of the Assignor's obligations under this Agreement and the proprietary interest of the Assignee in the Assigned Rights and so long as such obligations of the Assignor remain undischarged, or the Assignee has such interest, the power may not be revoked by the Assignor, save with the consent of the Assignee.
- 4.4 Without prejudice to Clause 4.2, the Assignee may, in any way it thinks fit and in the name and on behalf of the Assignor:
- 4.4.1 take any action that this Agreement requires the Assignor to take;
- 4.4.2 exercise any rights which this Agreement gives to the Assignor; and
- 4.4.3 appoint one or more persons to act as substitute attorney(s) for the Assignor and to exercise such of the powers conferred by this power of attorney as the Assignee thinks fit and revoke such appointment.
- 4.5 The Assignor undertakes to ratify and confirm everything that the Assignee and any substitute attorney does or arranges or purports to do or arrange in good faith in exercise of any power granted under this Clause.
- 4.6 The Assignor shall use reasonable endeavours to procure that the following domain names (which are registered in the name of Ankur Shar) are promptly transferred to the Assignee:

5 WAIVER

No failure or delay by a Party to exercise any right or remedy provided under this Agreement or by law shall constitute a waiver of that or any other right or remedy nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

6 ENTIRE AGREEMENT

- 6.1 This Agreement, together with the Sale Agreement, constitutes the entire agreement between the Parties and supersedes and extinguishes all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.

- 6.2 Each Party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this Agreement. Each Party agrees that it shall have no claim for innocent or negligent misrepresentation or negligent misstatement based on any statement in this Agreement.

7 VARIATION

No variation of this Agreement shall be effective unless it is in writing and signed by each of the Parties (or their authorised representatives).

8 SEVERANCE

- 8.1 If any provision or part-provision of this Agreement is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this Clause shall not affect the validity and enforceability of the rest of this Agreement.
- 8.2 If one Party gives notice to the other of the possibility that any provision or part-provision of this Agreement is invalid, illegal or unenforceable, the Parties shall negotiate in good faith to amend such provision so that, as amended, it is legal, valid and enforceable, and, to the greatest extent possible, achieves the intended commercial result of the original provision.

9 COUNTERPARTS

This Agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.

10 THIRD PARTY RIGHTS

This Agreement does not give rise to any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this Agreement.

11 NOTICES

- 11.1 Any notice or other communication given to a Party under or in connection with this contract shall be in writing and shall be:
- 11.1.1 delivered by hand or by pre-paid first-class post or other next working day delivery service at its registered office (if a company) or its principal place of business (in any other case); or
 - 11.1.2 sent by email to the address specified in the Sale Agreement (provided the email is supported by a valid server delivery receipt).
- 11.2 Any notice or communication shall be deemed to have been received:
- 11.2.1 if delivered by hand, on signature of a delivery receipt or at the time the notice is left at the proper address;
 - 11.2.2 if sent by pre-paid first-class post or other next working day delivery service, at 9 a.m. on the second Business Day after posting or at the time recorded by the delivery service; or
 - 11.2.3 if sent by email, at 9.00 a.m. on the next Business Day after sending.

- 11.3 This Clause does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any arbitration or other method of dispute resolution.

12 GOVERNING LAW

This Agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

13 JURISDICTION

Each Party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this Agreement or its subject matter or formation.

14 ADMINISTRATORS

- 14.1 The Assignee acknowledges that the Administrators are entering into this Agreement in their personal capacity solely to obtain the benefit of the assignment hereunder. The Parties agree that the Administrators are acting as agents of the Assignor and that neither the Administrators nor their firm shall incur any personal liability under this Agreement or under any document made to implement its terms whether such liability would arise under the Insolvency Act 1986 or otherwise.
- 14.2 The Assignee hereby agrees that the terms and conditions of this Agreement and the exclusions and limitations contained herein are fair and reasonable having regard to the facts that:
- 14.2.1 it is being entered into in the context of a sale by a company in administration in circumstances where it is usual in comparable circumstances that no representations, warranties and conditions express or implied statutory or otherwise are given by or on behalf of the Assignor or the Administrators (or any of them); and
- 14.2.2 the Assignor and the Administrators have informed the Assignee that the Assignee must rely absolutely on the Assignee's own opinion and/or professional advice concerning the matters contemplated by this Agreement.
- 14.3 The Parties acknowledge that nothing in this Agreement shall affect the powers and/or duties of the Administrators whether statutory or otherwise.
