



## DISTRIBUTION AND ASSUMPTION AGREEMENT


This Distribution and Assumption Agreement (this "Distribution Agreement") is entered into and effective as of 11:59:57 p.m. Boston time on January 3, 2015 by and among (a) Louis A. Maglio, Jr. ("Maglio"), (b) James E. Loer, Jr. ("Loer"), (c) Sidney A. Tildlsey ("Tildlsey"), (d) Robert L. Willis ("Willis"), and (e) Walpole Woodworkers, Inc., a Massachusetts corporation (the "Company"). Maglio, Loer, Tildsey and Willis are referred to collectively as the "Owners" and each as an "Owner".

Introduction
The Owners are all of the holders of capital stock of the Company. The Company owns and operates a commercial business for the manufacture, marketing and sale of fences, arbors and other high end outdoor products for retail customers (the "Commercial Business").
The Company wishes to distribute and assign up to each of the Owners, as shareholders of the Company, the Owners' respective pro rata percentages (based on Company stock ownership) of (i) all of the operating assets of the Company that are used, or held for use, by the Company in the Commercial Business,  For and in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:
1. <u>Distribution of Assets</u> . The Company hereby irrevocably distributes, transfers, assigns, conveys and delivers to the Owners subject to all existing liens, security interests, claims and encumbrances of any kind, (i) all of the right, title and interest of the Company in, to and under the operating assets of the Company that are used, or held for use, by the Company in the Commercial Business, of every kind and description wherever located and whether tangible or intangible or real, personal or mixed, and as the same shall exist on the date hereof, whether or not appearing on the books of Company,
and expressly including, without limitation, the assets listed or described on <b>Schedule I</b> attached hereto and incorporated by reference herein (such distributed assets, the " <b>Distributed Assets</b> "), to have and to hold the same unto the Owners, their respective successors and assigns forever,
