ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION

The number of shares that voted for the amendment was 100%.

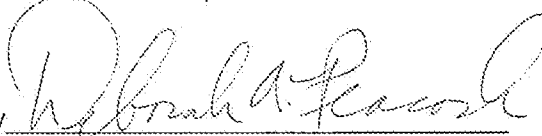
