And I agree, for myself and my executors and administrators, with Assignee and its successors and assigns but at its or their expense and charges, hereafter to execute all applications, amended specifications, deeds or other instruments, and to do all acts necessary or proper to secure the grant of Letters Patent in the United States and in all other countries to Assignee, with specifications and claims in such form as shall be approved by the counsel of Assignee and to vest and confirm in Assignee its successors and assigns, the legal title to all such patents. I further authorize and grant an irrevocable, perpetual, limited power of attorney, being coupled to an interest, to Assignee's attorney, **Jason A. Bernstein**, or his designee, to execute on my behalf any documents necessary to evidence authorship, inventorship or invention ownership (including declarations) and assignments granted herein for the United States or any other country without further notice to me and to fill in the application number and filing date above when obtained, even if after execution of this Agreement.

And I do hereby authorize and request the Commissioner for Patents of the United States to issue such Letters Patent as shall be granted upon said application or applications based thereon to Assignee, its successors and assigns. This assignment agreement may be executed in any number of counterparts and, and any party hereto may execute any such counterpart, each of which when executed and delivered shall constitute an original and all such counterparts together shall constitute but one and the same instrument.
