## **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Amended and Restated Intellectual Property Security Agreement (this "Termination"), dated as of February 15, 2019, is executed by SILICON VALLEY BANK, a California corporation ("Bank"), in favor of MINDBODY, INC., a Delaware corporation ("Debtor"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

### **RECITALS**

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of January 12, 2015 (the "Security Agreement"), by and between Debtor and Bank, Debtor granted to Bank a security interest in the IP Collateral (defined below).

B. The Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on January 11, 2018, at Reel/Frame 044603/0576, to evidence the security interest granted under the Security Agreement.

C. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on January 29, 2015, at Reel/Frame 005449/0406, on March 21, 2015, at Reel/Frame 005483/0204, and on January 11, 2018, at Reel/Frame 006248/0279, to evidence the security interest granted under the Security Agreement.

D. Bank agrees to execute this Termination in order to evidence the termination and release of its security interest in the IP Collateral specified below.

### **AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby agrees as follows:

(a) Bank expressly terminates and releases all of Bank's right, title and interest in, to and under the following (collectively, the "IP Collateral"):

(i) Intellectual Property (including without limitation those Copyrights, Patents, Trademarks and Mask Works listed on Exhibits A, B, C, and D hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

(b) Bank represents and warrants that it has the full power and authority to execute this Termination.

(c) Bank authorizes and requests the patent and trademark divisions of the United States Patent and Trademark Office, and the United States Copyright Office, to record this Termination.
