INTELLECTUAL PROPERTY ASSIGNMENT

With reference to the work the Royal College of Art (RCA) jointly owns in relation to the development and/or creation of **Gravity** a invention related to methods and apparatus for three dimensional image generation in particular for drawing a three dimensional image using a hardware and software combination - patent application number **PCT/GB2015/050162**> (the Work).

The RCA acknowledges that you wish to acquire the Intellectual Property Rights (as defined below) in the Work. The RCA agrees to assign the Intellectual Property Rights in the Work to you on the terms set out in this deed.

The following definitions apply in this deed:

Assigned Rights means all existing and future Intellectual Property Rights owned or to be owned in the Work.

Intellectual Property Rights means patents, rights to inventions, copyright and related rights, trade marks, business names and domain names, rights in get-up, goodwill and the right to sue for passing off, rights in designs, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered.

The RCA hereby assigns to you (by way of present and, where appropriate, future assignment) absolutely with full title guarantee all of the RCA's right, title and interest in the Assigned Rights.

The RCA waives all moral rights it has or may have in relation to the Work and shall procure that any third party it has engaged in relation to the Work shall waive any moral rights it has or may have in relation to the Work.

In consideration and within 5 days of the date hereof, you will issue **480** ordinary shares in the capital of **Gravity Sketch Limited** credited as fully paid in the name of Royal College of Art and enter Royal College of Art in the register of members in respect thereof. You will also provide to Royal College of Art a definitive share certificate in respect of the shares; and resolve to make all requisite filings at Companies House.

You grant to the RCA a non-exclusive, irrevocable and perpetual, payment-free, worldwide licence to do (and authorise others to do) in relation to copies or images of the Work any act restricted by the IPR in it for any non-commercial purpose associated with promoting the RCA, its activities, its students or their Work and preserving the RCA's and its students' Work.



This deed and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England.
