- (3) in and to any rights to sue for any past, present, or future infringement of any patents issuing from the Patent Application and any other patent applications in any jurisdictions on the Invention, including (but not limited to) the right to collect and receive any damages, royalties, or settlements for such infringements; any rights to sue for injunctive or other equitable relief; and any causes of action relating to any patents issuing from any the Patent Application or any other patent applications on the Inventions.

The Assignors confirm that the Assignee had the right to file the Patent Application and shall have the right to file additional patent applications on the Inventions in any jurisdictions.

The Assignors agree that the Patent Application and any other patent applications that may be filed on the Inventions under any applicable international treaties or conventions may be filed in the Assignee's name with the right to claim priority to the Patent Application.


protection, enforcement, and title in and to the Inventions and any rights hereby transferred.
