NOW, THEREFORE, in view of good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, we, the undersigned, have sold, assigned, and transferred, and by these presents do sell, assign, and transfer, unto said UNIVERSITY OF FLORIDA RESEARCH FOUNDATION, INC., its successors and assigns, the full and exclusive right to the said invention in the United States and its territorial possessions and in all foreign countries and the entire right, title, and interest in and to any and all Letters Patent which may be granted therefor in the United States and its territorial possessions and in any and all foreign countries and in and to any and all divisions, reissues, continuations, and extensions thereof.

We hereby authorize and request the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said UNIVERSITY OF FLORIDA RESEARCH FOUNDATION, INC., as the assignee of the entire right, title and interest in and to the same, for the sole use and behoof of said UNIVERSITY OF FLORIDA RESEARCH FOUNDATION, INC., its successors and assigns.

FURTHER, we agree that we will communicate to said UNIVERSITY OF FLORIDA RESEARCH FOUNDATION, INC., or its representatives, any facts known to us respecting said invention; testify in any legal proceedings; sign all lawful papers; execute all divisional, continuation, substitution, renewal, and reissue applications; execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said UNIVERSITY OF FLORIDA RESEARCH FOUNDATION, INC.; make all rightful oaths; and generally do everything possible to aid the said UNIVERSITY OF FLORIDA RESEARCH FOUNDATION, INC., its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.

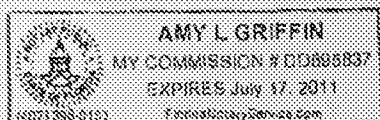

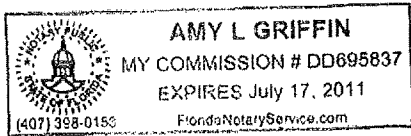


