## RELEASE OF PATENT SECURITY INTEREST

THIS RELEASE OF PATENT SECURITY INTEREST (“**this Release**”) is made as of February 19, 2019 by **CORBEL STRUCTURED EQUITY PARTNERS, L.P.**, as administrative agent (“**Agent**”) for the benefit of the Purchasers, holder of a security interest in and to the Patent Collateral, including, without limitation, the patents and patent applications set forth on the attached Exhibit A and incorporated in this Release by reference. 


