I authorize and request the Commissioner of Patents of the United States and the appropriate officers of all foreign patent offices to issue any and all Letters Patent


which may be granted on the said application or applications above referred to, or for said inventions, or any of them, to the said Assignee or its designee in accordance with the terms of this instrument.


