Patents in any country of the world and the right to recover, and take all such proceedings as may be necessary for the recovery of, damages and other form of relief in respect of all infringements of the Patents and to retain the same whether such infringements took place before or after the date of this Assignment TO HOLD the same unto the Assignee absolutely.

3. The Assignor hereby covenants with the Assignee that the Assignor will execute, sign and do, or procure the execution, signing or doing of all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee or the nominee of the Assignee to enjoy the full benefit of the property and rights hereby assigned and to enjoy the exclusive benefit of any extension, prolongation, registration or grant of patents for the time being invested in the Assignee by virtue of this assignment.
4. This deed shall be governed by and construed in accordance with the laws of England and Wales and the parties submit to the jurisdiction of the courts of England and Wales.




