ASSIGNMENT OF PATENT RIGHTS FROM INVENTOR TO GENERAL MANUFACTURING, LLC

Assignor authorizes and requests the Director of the United States Patent and Trademark Office, and any corresponding entity, agency, or official of any other country whose duty it is to issue patents or similar legal protection, to issue the patents to Assignee resulting from the Patent Application such that the patents will be held by Assignee for its own use and benefit, for the full term for which the patents are or may be granted.

2. Binding Agreement

The provisions of this Agreement are binding upon, and will inure to the benefit of, the Parties hereto and their respective heirs, personal representatives, successors and permitted assigns.

3. Counterparts
