

The said entire right, title and interest shall vest irrevocably in said Merrill Manufacturing Company. I further agree upon request, without additional compensation but at no expense to myself, to execute or assent to foreign applications, and to execute all other legal documents as may be necessary or desirable to vest the enjoyment of the said entire right, title and interest hereby transferred in Merrill Manufacturing Company, its legal representatives, successors and assigns, or as the said company may direct.

I hereby request the Commissioner of Patents and Trademarks to issue any Letters Patent of the United States which may be issued for said invention to the said Merrill Manufacturing Company, its legal representatives, successors and assigns, as the sole owner of the entire right, title and interest in and to said patents and inventions covered thereby.
