1.3 The Assignor agrees to provide any assistance reasonably required by the Assignee in order to give full effect to this Deed (including the execution of any documents). The Assignor irrevocably appoints each of the directors of the Assignee from time to time severally as the Assignor's attorney to do all acts and execute all documents which the Assignor is obliged to do or execute by this clause.
