WHEREAS, Hunter Douglas Inc., a Delaware corporation, having its principal place of business at 1 Blue Hill Plaza, Pearl River, NY 10965 (the "Assignee"), desires to acquire all rights, title, and interest of the Assignor in and to the Inventions and the Intellectual Property Rights;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold, assigned, and transferred and by these presents does hereby sell, assign and transfer to Assignee, and Assignee's legal representatives, successors and assigns, any and all rights, title and interest world-wide in and to the Inventions and the Intellectual Property Rights;

UPON SAID CONSIDERATION, Assignor hereby covenants and agrees with Assignee that it will not execute any writing or do any act whatsoever conflicting with these presents, and that it will, at any time upon request, without further or additional consideration, but at the expense of Assignee, execute such additional assignments and other writings and do such additional acts as Assignee may deem necessary or desirable to perfect Assignee's enjoyment of this grant, and render all necessary assistance in making applications for and obtaining proper protection with respect to the Inventions and the Intellectual Property Rights, and execute confirmatory assignments or acknowledgments of this assignment as necessary for full enjoyment of the Inventions and the Intellectual Property Rights and for recording in foreign patent offices, and in enforcing any rights or choses in action accruing as a result of the Inventions and the Intellectual Property Rights, by giving testimony in any proceedings or transactions involving the Inventions and the Intellectual Property Rights, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties;


UPON SAID CONSIDERATION, Assignor represents and warrants that Assignor has the right, title, and authority to execute this Assignment and to convey any and all right, title, and interest world-wide in and to the Inventions and the Intellectual Property Rights, and that Assignor has not executed and will not execute any agreement or make any conveyance in conflict with this Assignment; and

ASSIGNOR HEREBY AUTHORIZES Assignee, its successors, and assigns, or anyone it may properly designate, to apply for patents, design registrations, and other intellectual property rights associated with the Inventions and the Intellectual Property Rights in any country or region in the world, in its own name if desired, and additionally to claim priority to the filing date of the original application or registration and otherwise take advantage of the provisions of any international conventions.


