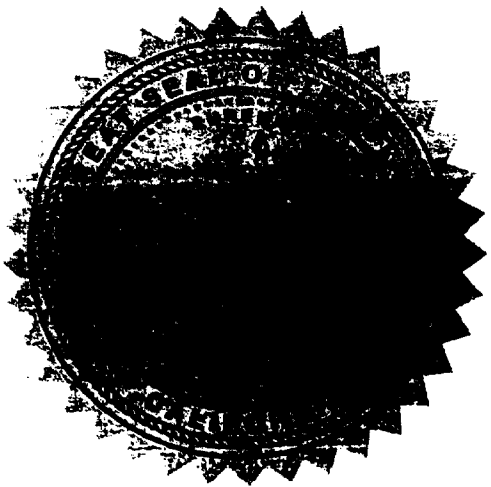

"ARTICLE I.

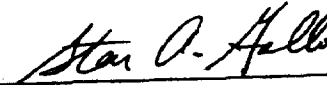
NAME
