AND ALL PRIORITY RIGHTS derived from U.S. Patent No. 8,083,266, and the applications therefor by virtue of the International Convention for the Protection of Industrial Property in any and all member countries of the aforesaid International

Convention and any other law, treaty or international convention, now existing or hereafter coming into being;

AND THE SOLE RIGHT to file additional patent applications arising from U.S. Patent No. 8,083,266 under the patent laws of any jurisdiction of the world in its name, and the sole right to have patents granted on such applications in its name to the full end of the term for which such patents may be granted as fully and entirely as the same would have been held by Chicago Fittings Corporation, had this assignment not been made, and to enforce U.S. Patent No. 8,083,266 and patents issuing from the patent applications with the right to sue for and recover for its own use and be granted injunctions, profits and/or damages for any and all infringement therefor, including, but not limited to, past and present infringements with respect to which Chicago Fittings Corporation hereby waives any right to receive any portion thereof.
