For good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, I hereby further sell and assign, *nunc pro tunc*, effective December 14, 2017, to **HOME DEPOT INTERNATIONAL, INC.**, a Delaware corporation, having its principal place of business at 2455 Paces Ferry Road, Atlanta, GA, 30339 ("**HD Int.**," and collectively with HDP A, "Assignees"), its successors, assigns, nominees, or other legal representatives, the entire right, title, and interest, outside the United States, in and to the invention invented by me, and any and all applications for patent, design and/or utility model therefor outside of the United States, the declarations, and all original and reissued patents granted therefor, and all divisions, continuations and continuations-in-part thereof outside the United States, including the subject-matter of any and all claims which may be obtained in every such patent, design and utility model, and the right to apply for and obtain corresponding patent which may be granted thereon outside the United States, as well as the sole and exclusive right to claim priority to any United States patent application therefor in connections with applications filed now or in the future outside of the United States, and authorize and request any official of any other country or countries foreign to the United States whose duty it is to issue patents, designs and/or utility models on applications as aforesaid, to issue said letters patent to HD Int., its successor, assigns, nominees, or other legal representatives, as assignee of the entire interest outside the United States herein assigned.

I covenant that I have not executed and will not execute any agreement in conflict herewith and agree that I will communicate to Assignees, their successors, assigns, nominees, or other legal representatives, all facts known to me respecting said invention, whenever requested, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths, and do all lawful acts requisite for the application for such divisional, continuing, or reissue applications, or the procuring thereof, and that if and when any of said Assignees, their successors, assigns, nominees, or other legal representatives desire to file a disclaimer relating thereto, I will, upon request, sign all lawful papers requisite for the filing of such disclaimer. I further covenant and agree that I will, at any time upon request, do everything legally possible to aid said Assignees, their successors, assignees, nominees, or other legal representatives to apply for, obtain, and enforce proper patent and/or utility model or design protection for said invention in all countries, all without further consideration but at the expense of said Assignees, their successors, assigns, nominees, or other legal representatives.

Assignor and Assignees hereby grant to the law firm of GREENBERG TRAURIG, LLP, authority and power to insert on this instrument any further identification which may be necessary or desirable for purposes of recordation in the United States Patent Office or the Patent Office of any foreign country.
