ASSIGNMENT AND AGREEMENT



We request that any and all patents for said inventions be issued to Adaptive Methods in the United States and in all countries foreign to the United States, or to such nominees as Adaptive Methods may designate.

We agree that, when requested, we shall, without charge to Adaptive Methods but at its expense, sign all papers, and do all acts which may be necessary, desirable or convenient in connection with said applications, patents, or other forms of protection.


