PATENT ASSIGNMENT

NOW, THEREFORE, in exchange for good and valuable consideration to the ASSIGNORS, the receipt and sufficiency of which are hereby acknowledged, the ASSIGNORS have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the ASSIGNEE, its successors, legal representatives and assigns, their entire, worldwide right, title and interest in, to and under the inventions and subject matter disclosed and claimed in the U.S. and PCT patent applications listed on the attached Exhibit A, and any other United States application to or from which priority is claimed under 35 U.S.C. §§ 119 or § 120, including all divisions, continuations, and continuations-in-part thereof, and all Patents of the United States which may be granted thereon and all reissues and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, inventor's certificates, and designs which may hereafter be filed for the inventions and subject matter disclosed and claimed in the U.S. and PCT patent applications listed on the attached Exhibit A in any country or countries other than the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from the U.S. and PCT patent applications listed on the attached Exhibit A under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such applications are filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for the inventions and subject matter disclosed and claimed in the U.S. and PCT patent applications listed on the attached Exhibit A in any country or countries other than the United States and all extensions, renewals and reissues thereof, the same to be held and enjoyed by the ASSIGNEE, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns,

to the full end of the term or terms for which Letters Patent or Patents may be granted as fully and entirely as the same would have been held and enjoyed by the ASSIGNORS had this sale and assignment not been made, including the right to sue for, settle and release all past, present and future infringement of the foregoing, including the right to license and to collect and receive damages, royalties, injunctive relief, and/or settlements for infringement thereof;

And the ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries other than the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

And the ASSIGNORS hereby covenant and agree that they have the full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, any agreement in conflict herewith;


