ASSIGNMENT OF SECURITY INTEREST AND ALL POSSESSED RIGHTS AND  
RELEASE

WHEREAS, TAR SITO LendCo LLC, a Delaware limited liability company, having an office for the transaction of business at 2200 Fletcher Avenue, Suite 501, Fort Lee, NJ 07024 (the "Assignor") of security interests and other rights (collectively "POSSESSED RIGHTS") in and to certain patents and patent applications of the Company which are listed herewith in Schedule A;

WHEREAS, certain UCC-1 financing statements (the "UCC-1s") were filed by or on behalf of Fortress Credit Co LLC, as Collateral Agent on October 3, 2014 and January 23, 2017, with the Delaware Secretary of State and the Nevada Secretary of State, against SITO Mobile Ltd., a Delaware corporation, having an office for the transaction of business at The Newport Corporate Center, 100 Town Square Place, Suite 204, Jersey City, NJ 07310 (the "Assignee"), which UCC-1s were assigned to Assignor on August 21, 2017; and

WHEREAS, Assignee, pursuant to the Settlement Agreement dated on or about February 20, 2018 by and between the Assignee, the Assignor, Mr. Julian Singer, Ms. Karen Singer and Mr. Gary Singer (collectively, the "TAR Group") (the "Settlement Agreement"), pursuant to which, among other things, that certain Revenue Sharing and Note Purchase Agreement dated October 3, 2014, as amended (the "Agreement"), was terminated and discharged, all liens were released, and all then pending litigation between the Assignee and the members of the TAR Group was dismissed in exchange for a lump sum payment of \$3.5 million paid by the Assignee to the Assignor, has secured the POSSESSED RIGHTS and is desirous of memorializing and/or recording the Assignee's entire right, title and interest in and to the POSSESSED RIGHTS and such termination and release.

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, BE IT KNOWN, that the Assignor, does assign, transfer and convey, unto the Assignee, its successors and assigns, the entire right, title and interest in and to the POSSESSED RIGHTS, and any and all improvements thereon, and in and to said applications and any applications claiming priority therefrom, and any other applications, divisions, continuations or continuation-in-parts thereof, and in and to any letters patent of the United States which may be issued on any of said applications, and any reissues thereof, and in and to any and all applications for letters patent filed in foreign countries for said inventions or improvements, including all priority rights under the Paris Convention, and any and all letters patent which may be granted in foreign countries therefor, TO HAVE AND TO HOLD THE SAME to the full end of the term or terms for which any and all said letters patent may be granted;

AND, the Assignor does hereby authorize and provide the POSSESSED RIGHTS to the Assignee, as the assignee of the entire right, title and interest in and to the POSSESSED RIGHTS, for the sole use and benefit of the Assignee, its successors and assigns and hereby authorize the Assignee to file for recordation with the United States Patent and Trademark Office and any other appropriate registry a copy of this

Assignment of Security Interest as evidence of the assignment by the Assignee of all of the Assignor's right, title and interest in and to the POSSESSED RIGHTS.

AND, the Assignor acknowledges that the indebtedness under the Agreement and the other Documents (as defined therein) is paid in full and all other obligations of the Assignee under the Agreement and the other Documents (as defined therein) are satisfied in full;

AND, the Assignor acknowledges that all of the liens filed against the Assignee in favor of the Assignor are automatically terminated and released with no further action;

AND, the Assignor acknowledges that Purchase Agreement and the other Documents (as defined therein) are automatically terminated, cancelled and of no further force and effect;

AND, the Assignor hereby authorizes the Assignee, or any other party on behalf of the Assignee, to prepare and file, as applicable, termination statements, releases and other instruments and documents (including, without limitation, Uniform Commercial Code termination statements) evidencing the aforementioned termination and release;


AND, at any time after the date hereof, the Assignor agrees to promptly procure, execute and/or deliver to the Assignee, from time to time, all further releases, termination statements, certificates, instruments and documents, and take any other actions, as may be reasonably requested by the Assignee or which are required to evidence the aforementioned termination and release, in each case at the sole expense of the Assignee (including reasonable and documented attorneys' fees and expenses); and

AND, Assignor hereby agrees that the terms or existence of the letter from Tom Pallack to Assignor dated March 4, 2019 shall remain confidential and that none of the information referenced therein shall be disseminated, given, shown, made available or communicated in any way to anyone, except to the extent required by applicable laws or regulations or by any subpoena or similar legal process or otherwise in connection with any litigation between the Assignor and the Assignee. Assignor understands and agrees that immediate injury will be caused to Assignee if the aforementioned information is divulged to any person or entity not a party to the letter. Assignor further agrees that any breach of this confidentiality provision shall constitute a material breach of this Assignment, and could subject Assignor and/or any agent acting on Assignor's behalf to any and all remedies at law or in equity that are available to Assignee.


