Assignor hereby agrees: (a) to communicate to Assignee, its successors and assigns, or their representatives or agents, all facts and information known or available to the Assignor respecting the Assigned Patent Rights; (b) to testify in person or by affidavit as required by Assignee, its successors and assigns, in any proceeding to obtain, enforce or defend the Assigned Patent Rights in the United States or any other country; (c) to execute and deliver, upon request by Assignee, all lawful papers including, but not limited to, original, divisional, continuation, and reissue applications, renewals, assignments, powers of attorney, oaths, affidavits, declarations, depositions in connection with the prosecution, enforcement, defense, and maintenance of the Assigned Patent Rights in any country; and (d) take such other action as reasonably necessary to evidence, record, or perfect the assignment hereunder and to otherwise provide all reasonable assistance to Assignee, its successors and assigns, in obtaining and enforcing proper title in and protection for the Assigned Patent Rights in any country.

Assignor hereby represents and warrants that he is the sole inventor of the above-identified patent applications and that Assignor has the full and unencumbered right to sell, assign, and transfer the above-identified patent applications and all other interests sold, assigned, and transferred herein, and that Assignor has not executed and will not execute any document or instrument in conflict herewith.
