Hughes Oilfield Operations LLC its successors, assigns or other legal representatives shall desire to file any application which claims the benefit of Application, including any divisional, continuation, or continuation-in-part applications or to secure a reissue of such patents, or to file a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such applications, or such application for reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

And we do further covenant and agree that we will, at any time upon request, communicate to **Baker Hughes Oilfield Operations LLC**, its successors, assigns or other legal representatives, such facts relating to said invention and patents or the file history thereof as may be known to me when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

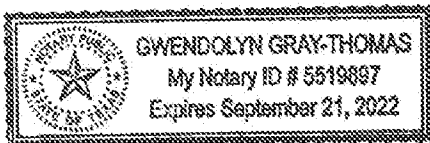
