## COMBINED DECLARATION AND CONFIRMATORY ASSIGNMENT

WHEREAS, we, ~~Rowland Hobbs~~, George Dy, Duke Sherman, and David Sonnenberg (collectively, the “Inventors”) have made certain new and useful inventions and improvements set forth in U.S. patents and patent applications, as set forth in Exhibit A hereto;

AND WHEREAS, in connection with some of the patents and patent applications set forth in Exhibit A, the Inventors have executed certain Assignments that have transferred the rights to Linea Photosharing LLC, a limited liability company in the state of Delaware and having a principal place of business at 1914 North 34th Street, Suite 200, Seattle, WA 98103;

AND WHEREAS, Linea Photosharing LLC was dissolved and all assets held thereby were transferred to successor-in-interest Linea Holdings LLC, a Delaware company having an office and place of business at 1 Blue Hill Plaza, Pearl River, NY 10965, in an instrument dated December 19, 2013;

AND WHEREAS, Linea Holdings LLC was dissolved and all assets held thereby were transferred to successor-in-interest Everson AG, a Liechtenstein company having an office at 1 Blue Hill Plaza, Pearl River, NY 10965, in an instrument dated December 20, 2013;

And WHEREAS, Everson AG was liquidated on November 22, 2016, with all assets held thereby transferring to sole owner and successor-in-interest, Ralph Sonnenberg;

AND WHEREAS, the Inventors and Ralph Sonnenberg (collectively, the “Assignors”) wish to convey, transfer, and assign to David H. Sonnenberg (hereinafter “Assignee”), and Assignee wishes to receive and own, among other assets, the entire right, title and interest in and to said inventions, improvements, patents, and applications set forth in Exhibit A hereto.

NOW THEREFORE, Assignors agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors, individually and collectively, hereby irrevocably convey, transfer, and assign to Assignee all of Assignors’ respective right, title, and interest in and to the following:

(a) the patents and patent applications set forth in Exhibit A hereto and all issuances, divisionals, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof, including all inventions described therein both in the U.S. and internationally (the “Assigned Patents”);

(b) all rights of any kind whatsoever of Assignors accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Assignors hereby authorize the Commissioners for Patents in the United States Patent and Trademark Office to record and register this Assignment upon request by Assignee. Following the date hereof, Assignors, individually and collectively, shall take such further steps and actions, and provide such further cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Patents to Assignee, or any assignee or successor thereto.

3. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

4. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


