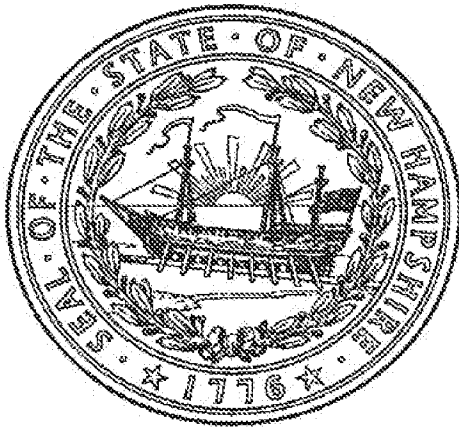

Pursuant to the provisions of the New Hampshire Business Corporation Act, the undersigned corporations adopt the following articles of merger:

FIRST: That the name and state of incorporation of each of the constituent corporations of the merger are as follows:

<u>NAME</u>	<u>STATE OF INCORPORATION</u>
Markem Tag, Inc.	Delaware
Markem-Imaje Corporation	New Hampshire

SECOND: That a plan of merger has been duly approved by the shareholders of Markem-Imaje Corporation in accordance with the requirements of Section 293-A of the New Hampshire Business Corporation Act and the articles of incorporation of Markem-Imaje Corporation, and by the shareholders of Markem Tag, Inc. in accordance with the requirements of the Delaware General Corporation Law and the certificate of incorporation of Markem Tag, Inc.

THIRD: That the participation of Markem-Imaje Corporation in the merger has been duly authorized as required by the laws of the State of Delaware.

FOURTH: That the name of the surviving corporation of the merger is Markem-Imaje Corporation, a New Hampshire corporation.

FIFTH: That the articles of incorporation of Markem-Imaje Corporation, as in effect immediately prior to the merger, shall be the articles of incorporation of the surviving corporation until amended in accordance with applicable law.

SIXTH: That a copy of the plan of merger will be made available to any shareholder entitled to vote on the merger upon the request of such shareholder to the president or secretary of the surviving corporation in the merger.
