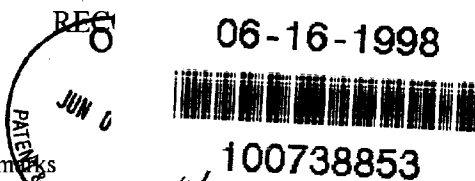



ASSIGNMENT

WHEREAS Peter Joseph Junger hereinafter ASSIGNOR) of 4820-150th Avenue, N.E. P.O. Box 957, Redmond, Washington 98052 has invented a certain improvement in METHOD AND APPARATUS FOR EFFICIENT HANDLING OF PRODUCT RETURN TRANSACTIONS for which a so-entitled application for Letters Patent of the United States was filed in the United States Patent and Trademark Office on April 24, 1998 under Serial No. 08/065,552;

And, ASSIGNOR hereby agrees to transfer a like interest upon request of said ASSIGNEE, its successors, assigns, and legal representatives, and without further remuneration, in and to any improvements, and applications for patents based thereon, growing out of or related to the said invention; and to execute any papers by ASSIGNEE, its successors, assigns, and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.

Agreeing, further upon request of ASSIGNEE, and without further remuneration, to execute any and all papers desired by ASSIGNEE, for the filing and granting of foreign applications and the perfecting of title thereto in ASSIGNEE.
