ASSIGNMENT

WHEREAS, WE, the undersigned inventors, having residence as set forth below, hereinafter referred to as "ASSIGNORS," have invented a certain new invention for:

LOCKING POSITION ADJUSTMENT DEVICE

ASSIGNORS also transfer to ASSIGNEE, its successors, assigns and legal representatives, without further remuneration, a like interest in and to any improvements, derivative works, and applications based thereon, growing out of or relating to the invention; and agrees to provide all

reasonable assistance and execute any papers, if accurate, desired by ASSIGNEE, its successors, assigns and legal representatives, to preserve, acquire and/or perfect ASSIGNEE's full protection and title in and to the invention and any improvements and to file any of the aforementioned applications.

ASSIGNORS also assign to ASSIGNEE, all right, title and interest in and to the Invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs throughout the world, including all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and ASSIGNORS further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in ASSIGNEE.





ASSIGNORS will communicate to ASSIGNEE, its successors and assigns or their representatives, any facts known to us respecting said invention and improvements; and, at the expense of ASSIGNEE, ASSIGNORS will fully cooperate in any legal proceedings, including any proceeding within the United States Patent and Trademark Office or other Patent Office anywhere in the world, relating thereto, sign all lawful papers, execute all non-provisional, divisional, continuing, continuations-in-part, reissue and substitute applications, make all rightful oaths and declarations, and, in addition, execute any and all documents required to vest title in ASSIGNEE and to aid ASSIGNEE to obtain and enforce proper protection for said invention in all countries.

ASSIGNORS authorize and requests the United States Commissioner of Patents and Trademarks, and such Patent Office officials in foreign countries as are duly authorized by their patent laws to issue patents, to issue any and all patents on said invention to the ASSIGNEE as the owner of the entire interest, for the sole use and behalf of the said ASSIGNEE, its successors, assigns and legal representatives.

ASSIGNORS covenant that ASSIGNORS have the full right to convey the interest assigned by this Assignment, and that ASSIGNORS have not executed and will not execute any agreement in conflict with this Assignment.

This Assignment shall be binding on the parties' successors, assigns and legal representatives.


