AMENDED AND RESTATED PATENT ASSIGNMENT

Assignor hereby irrevocably sells, assigns, conveys and transfers unto Assignee, its successors and assigns, the entire right, title and interest in and to the Patents, including any patents issuing from or based upon all patent applications thereon, and any continuations, continuations-in-part, divisions, reissues or extensions of the foregoing, and including, without limitation, the right to sue for and recover damages for any past, present or future infringement of the foregoing, the same to be held and enjoyed by Assignee for its own use, and for its legal representatives and assigns, to the full end of the term for which patents are granted, as fully and entirely as the as the same would have been held by Assignor had this assignment and sale not been made.

2. **MISCELLANEOUS**. If any provision of this Assignment is adjudged by any court of competent jurisdiction to be unenforceable or invalid, that provision will be limited or eliminated to the minimum extent necessary so that this Assignment otherwise remains in full force and effect and enforceable. This Assignment is deemed to have been made in, and will be construed pursuant to the laws of the State of Delaware without regard to conflicts of laws provisions thereof.

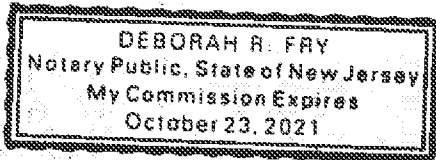
