RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE dated as of December 12, 2018 (this "Release") is made by Comerica Bank, a Texas banking association and authorized foreign bank under the Bank Act (Canada) (the "Secured Party") under the Amended and Restated Intellectual Property Security Agreement dated as of August 16, 2013 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Infobright Inc., a corporation existing under the Canada Business Corporation Act (the "Debtor") and recorded in the records of the United States Patent and Trademark Office at Patent Reel 033270, Frame 0205.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Patents, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Patents under the Security Agreement.
