ASSIGNOR hereby authorizes and requests the Commissioner for Patents and Trademarks to issue all patents based on said Applications to ASSIGNEE. ASSIGNOR agrees to execute all instruments and documents required for the making and prosecution of applications for United States and foreign patents based on the Applications, for litigation regarding the patents, or for the purpose of protecting title to the Applications or patents. If not already present, Assignor hereby authorizes the Assignee, or Assignee's attorney or agent, to insert the filing date and application number of the Applications when known.
