(d) any other United States Utility or corresponding foreign (including any patent application filed with the Japanese Patent Office), regional (including any patent application filed with the European Patent Office) or international patent application (including any PCT International Patent Application) claiming or applied for (nor or in the future) the Invention, or claiming priority to, or the benefit of the filing date of, (now or in the future) the Provisional Applications, Utility Application, or PCT International Application, including all divisions, continuations, continuations-in-part and substitutions thereof; and

(e) any and all United States and foreign patents which shall issue on said Invention or from any of the above-identified applications ((a) - (e)) including all reissues, reexaminations, renewals, divisions, continuations, and extensions thereof, for the United States, its territories and possessions and all foreign countries, including the right to file applications for Letters Patent on said Invention in any and all foreign countries and any other patent office, the same to be held and enjoyed by said ASSIGNEE, its assigns and

successors, as fully and entirely as the same would have been held and enjoyed by me, had this Assignment and sale not been made.

AND for the same consideration, each Assignor hereby represents and warrants to Assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, except for any rights, titles and/or interests that have arisen to Assignee under law or that have already been transferred to Assignee, Assignors are the sole and lawful owners of the entire right, title and interest in and to the said Invention and said application for Letters Patent above-mentioned (Filed Applications), and that the same are unencumbered and that Assignors have good and full-right and lawful authority to sell and convey the same in the manner herein set forth.

AND for the same consideration, each Assignor hereby covenants and agrees to and with Assignee, its successors, legal representatives and assigns, that Assignor will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of any Letters Patent and applications for Letter Patent for said Invention, without charge to Assignee, its successors, legal representatives and assigns, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise: that any proceeding in connection with said Invention, or any of said Filed Applications, or any proceeding in connection with any Letters Patent or applications for Letters Patent for said Invention in any country or patent office, including but not limited to interference proceedings, is lawful and desirable; or, that any division, continuation or continuation-in-part of any application for Letters Patent, or any reissue, reexamination or extension of any Letters Patent, to be obtained thereon, is lawful and desirable.

AND Assignors hereby request the Commissioner of Patent and Trademarks to issue said Letters Patent of the United States to Assignee, as Assignee of said Invention and the Letters Patent to be issued thereon, for the sole use and benefit of Assignee, its successors, legal representatives and assigns.


